A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORCO, CALIFORNIA, AMENDING FISCAL YEAR 2017-2018 GAS TAX FUND BUDGET WITHIN THE FISCAL YEARS 2018-2022 CAPITAL IMPROVEMENT PROJECTS BUDGET TO INCORPORATE A LIST OF PROJECTS FUNDED BY SENATE BILL 1, THE ROAD REPAIR AND ACCOUNTABILITY ACT

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April 2017 in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of Norco are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, Norco must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, in the City Capital Improvement Projects budget, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City previously included the estimated \$156,000 in RMRA funding in Fiscal Year 2017-2018 from SB 1 but the projects to be completed with said RMRA funds were not specified within the 2018-2022 Capital Improvement Projects Budget; and

WHEREAS, the State requires the City create an SB 1 project list and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials and practices, will have significant positive co-benefits statewide.

NOW, THEREFORE, BE IT RESOLVED the City Council of the City of Norco, State of California, does hereby determine as follows:

SECTION 1: The Gas Tax Capital Improvement Fund Budget for fiscal year 2017-2018 is amended to incorporate the list of projects planned to be funded with Road Maintenance and Rehabilitation Account revenues (Exhibit A).

SECTION 2: While the entire amount of projected RMRA funds has been allocated to one of the three projects, any of the three projects is eligible to use all or a portion of the available RMRA funds.
